**LET'S TALK TRASH!**

The Commissioners will be holding a special public meeting on April 7, 2010 beginning at 6:00 p.m. in the Library to discuss the Town's trash policy. The Commissioners are encouraging all residents to attend the meeting and to bring your thoughts and ideas on ways to improve on our trash removal and to make St. Michaels a more beautiful place for everyone. The Dinghy Docks located in the corner of the harbor between the Museum and The Crab Claw are now new and improved! In case you didn't know, the docks are used as transient tie-ups for dinghy users to visit and walk into town. The floating docks move up and down on stationary guide poles and do not move away from the bulkhead, thus making them safer. This project was funded by a grant from The Maryland Department of Natural Resources.

**Reduce – Reuse – Recycle**

Recycling saves energy, reduces the strain on our landfill, and creates jobs. Paper accounts for 40% of the solid waste in the US, which is about 72 million tons annually. If every household replaced just one roll of regular toilet paper with one recycled post-consumer waste roll, 424,000 trees would be saved. On the Eastern Shore, we have a company that will use as much paper as the counties can provide to recycle into new products. Cardboard (NO pizza boxes) is only accepted at the Mid-shore Landfill, but igloos throughout the county are waiting for each of us to pitch in and recycle our paper, magazines and newspapers. Small efforts do make a difference.

**2010 CENSUS**

Did you know that being counted in this census is important to your community in numerous ways? Being counted in the census can mean dollars for your community through Federal funding for hospitals, schools, roads, bridges and emergency services. In addition, residents can use census data to support community initiatives involving environmental legislation, quality-of-life issues and consumer advocacy. Remember that participation isn't just important – it's mandatory.

Registration of qualified voters may also take place at the office of the Talbot County Election Board, 142 N. Harrison Street, Easton, MD 21601 from 8:00 a.m. to 4:30 p.m. on regular business days.
